**Cancellation & Make Up Policy.** Buyer may cancel this agreement and receive a full refund within 3 business days from purchase. Missed classes may be made up by pre-scheduling to attend another class date/time during the session time period only. Missed classes may not be made up during another session time period and will not be refunded or pro rated .

**Party/Event Cancellation Policy.** A fifty percent deposit must be given at time of booking. The remaining balance is due the day of the event. All cancellations must be made ten days prior to event in order to receive a refund on the deposit. If the cancellation is done less than ten days then customer may reschedule the event within 6 months of original date.

**Health Warranty.** The parent or guardian/buyer warrants that the participant(s) or any family member or guest entitled to use the facilities of the club, has no disability, impairment or ailment preventing such person from engaging in active or passive exercise that would be detrimental inimical to such person’s health, safety or physical condition, or to the safety or health of other members of the club if such person does engage or participate in such exercise.
